

## Stephen G. Miller '61



Stephen Miller, a professor emeritus of classics who for nearly 50 years led UC Berkeley's archaeological excavation in Greece of a site of the ancient Panhellenic Games, died Aug. 11 in a Greek hospital. The Greek Reporter, an international news outlet, reported that 79-year-old Miller died that morning following a hemodialysis treatment. Miller retired from

Berkeley in 2004, and he and his wife, Effie, had been living in a home they'd built that overlooks Berkeley's archaeological complex in the tiny agricultural village of Ancient Nemea, in the northeastern part of Greece's Peloponnese. One of Miller's most widely-known contributions to Greek history was his promotion of and work to establish the modern international Nemean Games, a recreation at the archaeological site of the ancient foot races that gave birth to today's Olympics. The first races were held there in 1996 and drew more than 650 runners, most of them untrained, who were from 29 countries and ranged in age from 10 to 93. Designed to be held every four years, like the modern Olympic Games, the Nemean Games feature judges, heralds and trumpeters dressed in ancient-looking garb. In 1996, the inaugural runners, who competed in togas and barefoot, included then-U.S. Ambassador to Greece Thomas Niles, then-Berkeley Chancellor Chang-Lin Tien and 1968 U.S. Olympic track coach Payton Jordan.
