
Our commitment to exceptional stewardship means investing your gifts wisely and prioritizing financial transparency.

Despite navigating a volatile market environment in 2024, the Foundation's diversified investment portfolio produced a strong net investment return of approximately \$7.1 million. Total assets grew to more than \$82 million, with over \$4.2 million allocated to programs, fundraising, and administrative support. TOTAL NET ASSETS





Oversight of our financial operations is led by the Board of Trustees and dedicated standing committees that ensure transparency, accountability, and strategic investment of your contributions for maximum impact.

The dollars entrusted to the Foundation are gifted to achieve specific purposes that advance each chapter's or donor's charitable intent and further Phi Psi's vision of inspiring men to strive for their highest intellectual, moral, and spiritual character in order to live productive, honorable, and purposeful lives.

These purposes have different timeframes, and some carry unique restrictions. Some are very short-term, while others are longer and some are perpetual in nature. As a result, the Foundation's assets are invested in one of five investment pools with asset allocations consistent with these purposes. These allocations are rebalanced to targets when appropriate.

LIVING & CREED

TO GIVE AID AND SYMPATHY, A BROTHER TO ALL

When Nicholas Rohlwing *Illinois '22* reflects on the Creed of Phi Kappa Psi, one line rises above the rest: "To give aid and sympathy to all who are less fortunate."

"For me, that's the heart of it all," said Nick, now a junior at the University of Illinois. "It's the underlying reason I want to become a doctor. I want to make a real difference in my time on earth."

Nick's path hasn't been easy. After suffering a traumatic brain injury in middle school, he endured a grueling, months-long rehabilitation process — an experience that could have left him bitter, but instead sparked a calling. He saw firsthand the power of compassion, watching the unwavering commitment of the doctors and caregivers who helped him heal.

That calling deepened as he watched his mother live with multiple sclerosis, showing strength through adversity every day. These experiences shaped not only Nick's career aspirations but also his character — grounded in empathy, service, and a drive to uplift others.

Nick's story is a powerful reminder that through hardship can come purpose — and that the values of

Phi Psi are not just words, but a way of life. Last year, Brother Rohlwing was awarded the Mark Stevens *USC '81* Undergraduate Scholarship for \$5,000. This National Scholarship award recognized his financial need as well as his achievements and service to Illinois Delta and his community.

It's been quite a journey — especially for someone who hadn't initially planned on joining a fraternity.

"I really wanted to focus on school," Nick says. "But after going to a few Phi Psi events, I felt a connection. Meeting other pre-med majors in the chapter has been huge — it's created a sense of community and shared purpose."

For Nick, that sense of purpose goes far beyond academics. One of the most meaningful parts of his Phi Psi experience has been the chance to show up for others.

"Actively contributing to others' well-being is something I strive to embody in my day-to-day life — through service, empathy, and support," he shared. "I believe in the difference one person can make. I want to 'be a brother to all."

Nick lives those words in every corner of his life. From volunteering in a church soup kitchen to educating peers about homelessness, assisting individuals with disabilities, and even supporting groundbreaking research to repurpose a tuberculosis medication for antifungal use, Nick's commitment to serving others is both wide-reaching and deeply personal.

What began as a decision to attend a few fraternity events has grown into a brotherhood and a mission — a reflection of the Creed, and a life dedicated to making an impact. "In addition to his academic and research achievements, Nicholas exhibits excellent interpersonal and communication skills," observed one of Brother Rohlwing's professors. "He effectively collaborates with team members ... and demonstrates adaptability in addressing unforeseen challenges. Further, he consistently exhibits kindness and a genuine desire to help others ... I do not doubt that he will continue to excel in academic and professional pursuits."

Chapter Advisor Todd Salen *Illinois '77* wrote that Nick is "deeply devoted to helping other people and works hard to acquire the knowledge he needs to contribute at a higher level."

When it comes to expressing gratitude for the alumni whose generosity made his scholarship possible, Nicholas speaks with both humility and intention.

"I want them to know I plan to pay it forward — to help make the same opportunity possible for another brother one day," he said. "And I hope they can see through my daily commitment to academics and my future career just how seriously I take this gift."

For Nick, the scholarship is more than financial support — it's a vote of confidence that fuels his motivation.

"Their generosity has gone to someone who truly values it. It's easing the burden of financial stress now and helping reduce the debt I'll carry in the future. I'm extremely appreciative."

Nick's words — and his actions — reflect a deep understanding of the ripple effect that support can create. His gratitude isn't just spoken — it's lived, every day.

own outreach efforts in Tuscaloosa, solidified his commitment to making a meaningful impact through the legal system.

Driven by Phi Psi's core values, Nate consistently seeks to foster goodwill and support those around him — both on campus and in the chapter house. "I've tried to build a culture of generosity and compassion," he shared. "I want to create a positive, welcoming environment that inspires others to get involved, to serve, and to lead."

Through his academic excellence, leadership, and dedication to service, Nate is not only preparing for a future in public law — he's already living out Phi Kappa Psi's mission to be a man of honor, compassion, and action. With a spark of ingenuity and a keen entrepreneurial spirit, Nate recently launched a sustainable initiative that gives new life to used sawdust from the University's woodshop. Instead of heading to the landfill, the sawdust is now repurposed as bedding for horse stalls at Therapeutic Riding of Tuscaloosa (TROT), a nonprofit that offers behaviorally oriented therapy through interactions with specially trained horses and instructors.

"This project called for careful planning, strategic negotiation, and the creation of a lasting partnership between the University and TROT," Nate explained. "Bringing it to life has been a major milestone in my professional journey, showing me firsthand how entrepreneurship can drive meaningful success while giving back to the community." Marguerite Malone, Ph.D., serves as clinical director of the equestrian nonprofit where Nate volunteers. "Nate is one of the most dedicated and broadly knowledgeable of those with whom I have worked. He has served as a mentor to youth in our program and as our liaison to the large community service organization at the University of Alabama. Nate endeavors to bring different organizations and populations together in ways that better his community and the global community as a whole."

Chapter Advisor and House Corporation Treasurer Patrick Adcock *Alabama '04* couldn't agree more. "Nate truly embodies the ideals of our Creed," he said. "He likely spends more time serving others than anyone else in the chapter — yet still maintains one of the highest GPAs. He's remarkably organized, deeply involved, and one of the most dedicated undergraduates I've had the honor of working with. His commitment to both our campus and our chapter is unwavering."



CLIMBING HIGHER

A PATH TO SERVING OTHERS

Brother Ian Risser *Ohio State '17*, a fourth-year medical student at the University of Toledo Medical School, stumbled upon an exciting opportunity while browsing a Phi Psi e-newsletter last spring. It was there that he discovered the Phi Psi Foundation's Shane Yates Fellowship.



He was awarded the Yates Fellowship in the amount of \$1,500 in time to attend the first of those extraordinary experiences.

lan's passion for adaptive sports and the Special Olympics played a major role in shaping his academic journey. When he enrolled at The Ohio State University in late 2016, he chose to pursue the challenging field of biomedical engineering with a clear goal in mind: helping people overcome their challenges so they could engage in the activities they love.

Initially, Greek life wasn't part of his college plan, but that changed during the spring recruitment of 2017. After meeting several accomplished upperclassmen from Ohio Delta, lan saw firsthand the professional drive and camaraderie within Phi Kappa Psi. Inspired by their success and character, he made the decision to join — a choice that would shape both his college experience and his future career.



"Adam Steinle was the chapter president at the time — a biomedical engineering major and one of the smartest people I've ever met," Ian recalled. "Being in Phi Psi gave me mentors and career exploration opportunities I wouldn't have otherwise had."

By the end of his sophomore year, Ian's Phi Psi experience had already opened doors. He had the opportunity to attend the Nelson Leadership Academy's PIVOT program in Orlando, where he connected with remarkable individuals from across the country. "That experience truly broadened my perspective — not just on my own potential, but on the depth and impact of the Phi Psi brotherhood."

Brother Risser reflects on his engineering background as a defining part of his journey. "The major pushed students, like me, out of their comfort zones and forced me to expand my problem-solving skills," he said. That love for tackling complex challenges ultimately guided him toward orthopedic surgery.

"While studying physiology and preparing for the MCAT, I realized just how intricate the human body is," Ian shared. "I wanted to know more." His curiosity and drive paid off — he graduated magna cum laude from Ohio State and went on to earn invitations to two prestigious honor societies during medical school, further cementing his path toward a career dedicated to solving complex medical challenges.

Why orthopedic surgery? "I believe the ability to live one's life to the fullest is centered around the ability to



move and complete activities. During my rotations, I worked in some of the country's most advanced trauma centers treating the worst injuries. I saw the dedication and skill of ER doctors and surgeons at work. As a physician and a Phi Psi, I want to continue learning — and to do as our Creed says, to give aid and sympathy to all who are less fortunate."

During medical school, Ian leveraged some of the leadership skills he gained at Ohio Delta to co-create the nonprofit organization Northwest Ohio Adaptive Climbing. Today, he serves as its president. The organization is dedicated to empowering individuals with intellectual and physical disabilities through the transformative experience of rock climbing. "We believe that every person, regardless of ability, deserves the opportunity to embrace the thrill of ascending to new heights and discovering their resilience."

Ian expresses his deep gratitude to the alumni who made his fellowship possible and to the Phi Psi Foundation for making grants like this known to brothers of all ages. "Honestly, if I hadn't read that alumni email, this wouldn't have been on my radar at all. Receiving the Shane Yates award has removed some of the additional financial burden of my rotations, allowing me to focus more on excelling as a student, future resident, and coworker. I'm very thankful for those alumni supporting my professional endeavors and for allowing me to become someone who can give back to others."

ADDRESSING CRITICAL NEED

TRANSFORMING YOUNG PHI PSIS INTO CONFIDENT LEADERS

In a recent survey of 1,000 business managers, about half say that today's workforce candidates lack the overall professionalism needed to be successful in their roles.

Specific findings included:

81% say recent college graduates need workplace etiquette training.

56% contend this demographic is somewhat or highly incompetent at taking constructive criticism.

40%-48% cite incompetence in resolving conflicts, arriving on time, separating their work and home lives, dressing professionally, and exercising common sense in the workplace.

Generous alumni are helping Phi Psi address these concerns in a powerful effort to build leadership and interpersonal skills among its youngest members.

The *Launch* program, piloted in the fall of 2024, welcomed 31 Phi Psis from five chapters to Camp Tecumseh in Brookston, Indiana, for a multi-faceted leadership learning weekend.

Guided by facilitators, staff, and alumni volunteers, participants spent three days developing leadership skills and making new connections with peers from nearby Phi Psi chapters.

The multi-day *Launch* program was designed to inspire impact through dynamic learning, reflection, and connection. With a mix of small-group conversations and large-group discussions, participants were immersed in high-energy, rapid-fire lessons from the moment they arrived.

Here's how the transformative journey unfolded:

DAY 1: LAYING THE FOUNDATION

The program kicked off by introducing *Launch's* structure and goals, setting the tone for a weekend of growth. Participants discovered the Adaptive Leadership Model and gained insight into their unique leadership styles using the True Colors Assessment. The day wrapped with honest conversations about identifying and tackling chapter challenges, managing personal wellness, and preparing for the real-world demands of leadership.

DAY 2: LEADING WITH PURPOSE

Day two focused on practical leadership skills. Participants explored how to build buy-in, manage conflict, and lead through values. They also learned to identify key stakeholders, celebrate progress, and inspire others. The day culminated in a high ropes course — an exciting, hands-on team-building experience that tested their communication, trust, and resilience in the great outdoors.

DAY 3: TURNING INSIGHT INTO ACTION

The final day focused on bringing it all together. Through time management exercises and goal-setting sessions, participants developed personal blueprints outlining their future academic, fraternal, professional, and personal ambitions. The weekend closed with a challenge: to take the tools they'd gained and drive positive change in their chapters, on campus, and in their communities.



Feedback from surveyed participants was resoundingly positive. Many called it one of the most enriching leadership opportunities they've experienced and strongly recommended that it continue.



Since the program's conclusion, 65% of attendees have taken on a leadership role within their chapter.

These programs aren't just nice-to-have — they're essential. Initiatives like these are critical to ensuring today's brothers graduate with more than a degree. They leave college equipped with the interpersonal and professional skills they'll rely on for a lifetime.



FORGING LEFUTURE

LIVE EVER. DIE NEVER. A STRONGER TOMORROW.

Leading with the Fraternity's beloved and powerful battle cry, alumni leaders at Phi Psi's West Virginia Alpha Chapter launched a historic campaign to ensure sustained excellence in the post-pandemic era.

Their goal? To position the chapter's housing and educational funds for long-term success, making it the most resourced chapter on the West Virginia University campus.

With chapter leadership typically consisting wholly of volunteers, major fundraising initiatives can seem daunting, to say the least. However, the Phi Kappa Psi Foundation Chapter Development Services team was a pivotal partner, providing integral planning and execution resources to help ensure the process. For West Virginia Alpha, the Phi Psi Foundation served as counsel and communications lead for the campaign, managing all aspects from start to finish.

West Virginia Alpha was the University's first fraternity. It has enjoyed a long and storied history, as past University President E. Gordon Gee noted in the campaign case statement:

"Since 1890, Phi Kappa Psi has been a stalwart member of the Greek system at this University ... providing a residence for brothers while instilling lifelong bonds of friendship and loyalty ... [You] now embark on a campaign to meet both the changing needs of the chapter residence and the financial challenges of many of its undergraduate students."

"This Fraternity has always been about attracting the best and brightest," noted Campaign Chairman Tim Miller WVU '74. "If we want to get those people, it requires having a modern facility, a place where our brothers can gather — a place to call home. We must become ever more relevant and resilient."

Final results were announced in January 2025, with 152 donors making cash gifts and pledges totaling just over \$1 million to ensure a stronger tomorrow.

The influx of new resources comes at a pivotal time. Greek-letter organizations must evolve to meet

members' growing needs in an age of increasing complexities, competition, and challenges across the campus landscape. As alumnus Alex Greenberg WVU '07 noted, "Colleges across the country are revamping what it means to be in a fraternity. The old model was not sustainable. We have a unique opportunity to lead by example — demonstrating what it means to be a true fraternity by prioritizing scholarship, character, and the values of a gentleman."

Former National Phi Kappa Psi Fraternity President David Woodrum *WVU* '61 noted that the fraternal mission is complementary to that of the college. "The Fraternity is subordinate to the University. We're not equal to or better than. We want to emphasize scholarship, and we want to be able to support students who are scholars."

Facility improvements will provide each student member with a safe environment to learn and thrive in their educational experience. A new sustainable revenue model will also strengthen the chapter and help retain some members who otherwise may be unable to meet the financial obligations of their education. Academic success and retention are goals for all student Phi Psis.

WVU Board of Governors member Rick Pill *WVU '70* offered his encouragement. "The money will be used properly to help other people. There are a lot of great organizations where you can donate your money. [Phi Kappa Psi] will help people, and you've been there. You need to help others just like the people before us helped us."

A LEGACY OF GRATITUDE

BROTHERHOOD INSPIRING GENEROSITY

When Wes Schaub *Toledo '80* came to the largely commuter campus of the University of Toledo in 1979, he was eager to get involved in Greek life. Hailing from North Canton, Ohio, Brother Schaub said he looked at other groups but felt most comfortable with the brothers of Phi Kappa Psi.

"I held a variety of offices as an undergraduate, which ended up encouraging me to get involved in student government, the Interfraternal Council, and other organizations on campus."

After he graduated in 1984 with a degree in architectural history, he took what he called "a hiatus" from his involvement with the brotherhood. "I maintained some chapter friendships," he said, "but I really didn't think about doing anything beyond that."

Wes pursued a graduate degree in higher education and then served as Director of Greek Life at Case Western Reserve University (CWRU). "In the mid-1990s, I was asked by Phi Psi to get involved in what was then the Woodrow Wilson Leadership School. By then, I felt it was my duty to give back. I volunteered for a couple of years, taking up the challenge of helping our younger brothers improve their life skills. That got me re-engaged at the national and local levels."

Remembering when he received a Phi Psi National Scholarship during his Ohio Eta undergraduate days, Brother Schaub began making regular gifts to the Phi Kappa Psi Foundation. "Scholarships are important. I remember how much that support meant then. It's still important."

Brother Schaub credits Phi Kappa Psi for guiding him toward the fulfilling career he enjoys today. As a way of giving back, he recently included the Phi Psi Foundation in his will, joining the Foundation's Summerfield Society and ensuring future generations of scholars benefit from his generosity.

"A Phi Psi email introduced me to the idea of creating a free will online. It's something many people put off, but I've reached a point where I need to decide what happens to my legacy. Using the FreeWill program made the process simple. Without Phi Psi, I wouldn't

have found the career path that shaped my life. That's why supporting the Foundation was an easy choice—it's always been one of the organizations closest to my heart."

Wes is adding to his Phi Psi legacy by leaving the Foundation his extensive collection of Greek memorabilia, including letters from Phi Psi founders and hand-painted steins. "I also have around 2,000 fraternity badges. Many are from Phi Psi, but there are also others. A most interesting item is a photo yearbook that belonged to a Phi Psi in the 1880s. It is filled with wallet-size photos the member collected from friends that year."

In his current role as a chapter advisor at CWRU, Brother Schaub uses the Phi Psi Creed to encourage young men to think more deeply about their lives.

"Our founding principles are still relevant, still important. I often ask young brothers to reflect on what various lines from our Creed mean for them in their lives — loyalty to the brotherhood and to the university, for instance. I try to get them to translate

those ideals into meaningful actions. I also try to help them realize that being part of any fraternity represents being part of ALL fraternities. Collectively, we have an obligation to present ourselves in ways that bring respect to our individual organizations and to the larger Greek world."

How would he encourage fellow alumni to consider what their fraternal legacy will be? "I would say if you had a positive experience, one memorable enough to keep you involved, that giving back in this way is a good way to thank the organization for its influence in your life. When you join a fraternity, even if you don't mean for it to influence who you are as a person, it still does.

"To acknowledge all you've gained by providing for its future existence is a good thing."

Brother Wes Schaub has served as an academic advisor since 2017 and currently holds the position of Associate Dean at Case Western Reserve University. He is a member of the Fraternity's Order of the S.C. and volunteers his time and expertise in service to Phi Kappa Psi's Ohio Epsilon Chapter.









CREATING A LEGACY

"I wish to make possible a college course for a number of worthy boys," wrote Solon E. Summerfield *Kansas 1899*, "to aid youth to prepare for useful living."

During his undergraduate years, Brother Summerfield was often thought of as a young man who never bothered his teachers and never gave them cause to bother him in return. He was a reserved man, and certainly surprised his Phi Psi brothers when he later became one of the Fraternity's greatest benefactors. Like so many alumni, he was proud of his Phi Psi experience at the University of Kansas and later remembered the brotherhood through a legacy estate gift. Summerfield felt Phi Psi was one of the major reasons for his later success in the business world.

Brother Summerfield's success would come a few short years later in the early 1900s, a time when silk stockings were becoming a popular fashion accessory. Summerfield decided to stake his future on this fashion staple. His hard work and entrepreneurial spirit led to the establishment of the Gotham Silk Hosiery Company. Now, even after his death, his legacy profoundly impacts the lives of undergraduate Phi Psis.

CASH CONTRIBUTIONS

The simplest way to support Phi Psi is to make a cash gift in the form of a multi-year pledge or one-time gift.

YOUR DONOR-ADVISED FUND

Donor-advised funds have become an increasingly popular way to realize personal philanthropic goals in recent years. If you have a donor-advised fund, you know grants are easy to make. We are a qualifying charitable organization, eligible to receive your grant, and your support will help Phi Psi when it needs it most. Since your grant comes from funds that have already been set aside for charitable giving, there is no change in the assets you have available to meet daily needs or realize future financial goals.

When you make a donor-advised fund grant to the Foundation, please let us know and be sure to designate your gift to the fund of your choosing.

PLANNED GIFT

There are gift planning options that are specifically designed to focus on future benefits. Many of these options are simple to implement as part of your longterm planning.

- A will or living trust is a roadmap for distributing your property and can be used to make a gift that supports Phi Psi in a meaningful, personal way.
- One of the simplest but most often overlooked opportunities for making a meaningful charitable gift is to name us as a beneficiary of an existing life insurance policy, retirement account, donor advised fund account, or bank account.

APPRECIATED STOCK

A gift of appreciated stock held more than one year is a tax-wise way to make a gift that helps Phi Psi today. When compared to making a gift of cash, a gift of appreciated stock provides a very important benefit: you pay no capital gains tax on the appreciated value of the stock. In addition, when you itemize your tax return, the gift qualifies for a deduction equal to the stock's current value, even though no tax has been paid on the appreciation.

EXAMPLE: Brother Williams purchased stock in a tech services company five years ago for \$10,000. The company has enjoyed extraordinary success and the stock is now worth \$40,000. Brother Williams decides it is an ideal time to support Phi Psi. He makes a gift to the Foundation of half the stock—a gift valued at \$20,000, with a basis of \$5,000. Because he itemizes his return, Brother Williams' gift qualifies for a deduction of \$20,000 and he pays no capital gains tax on the \$15,000 of appreciation.

IRA DISTRIBUTION

If you are an IRA owner age 70½ or over, making a gift through a qualified charitable distribution (QCD) is an option worth considering. You benefit because there are some distinct advantages that accompany this gift option.

- Although there is no tax deduction, the amount transferred is excluded from your income for federal tax purposes—you owe no tax on the transfer!
- The amount you give counts toward your required minimum distribution (RMD) when one is due. (Under the SECURE Act passed in 2019, RMDs must begin at age 72.)
- Transfers up to \$100,000 (annual aggregate limit) qualify for this favorable tax treatment each year (but contributions to an IRA after age 70½ reduce QCD amounts).
